Documentation: A valid U.S. passport, valid for six months beyond date of return is required. All passengers are required to fill out a Passenger Immigration Form prior to final payment.

Air schedules & seat assignments: Group air has been blocked for this cruise. Group air rates are subject to a minimum number of passengers and failure to reach this minimum may result in higher airfare. The airlines block many rows of seats to be assigned at check-in only, providing those with less desirable sets the possibility of changing their seat assignments upon check-in.
