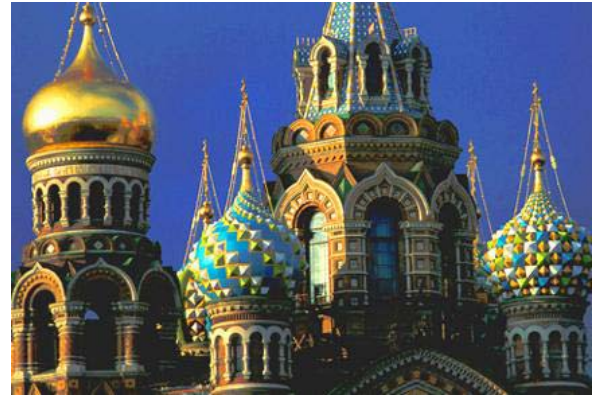

**DEPOSIT:** \$750.00 per person, insurance premium, if chosen (non-refundable) along with completed Reservation Form and copy of your passport, if available.

**FINAL PAYMENT:** Due March 23, 2012.

**NOT INCLUDED:** Alcoholic beverages including wine, beer and soda, items of a personal nature such as laundry, phone calls, etc. gratuities other than included traditional shipboard gratuities for ship's crew, spa services, cost of passports or visas, optional shore excursions, deviation or change fees, increases in taxes or fuel surcharges, baggage fees or anything not specifically indicated as included. Space based on availability.

**PROOF OF CITIZENSHIP:** A U.S passport, valid for six months from your date of return, is required. An additional form of picture I.D., such as your driver's license may be requested by airport security. Non-U.S. citizens should contact their consulate.

**PASSENGER IMMIGRATION FORM:** All passengers are required to fill out a passenger immigration form prior to final payment.

**SECURITY FEES & TAXES:** Are subject to change without notice.

**AIR SCHEDULES & SEAT ASSIGNMENT:** Flights are arranged through the cruise line and are at the discretion of the cruise line; schedules do not become available until 30 days prior to departure and clients may not end up traveling together. Seat requests cannot be guaranteed. The airlines, now more than ever, block many rows of seats to be assigned at check-in only. We will do our best to honor requests.

**DEVIATIONS:** Any deviations are subject to \$100.00 pp service fee as well as any additional costs that would apply. Any unused portions of the packages are non-refundable.
